### **Applications:**

- All vendors will be notified of acceptance via email or phone.
- Booth selection and placement is final and is at the discretion of the event coordinator.
- If vendor is not selected to participate in Silt Heyday the application fee will be returned.

### **Set-up:**

Friday, August 18<sup>th</sup> 3:00 p.m. to 9:00 p.m. unless other arrangements are made

- All vendors must check-in prior to set-up to receive their booth assignment
- All vehicles must be removed from the park by 9:00 p.m. Friday
- Tents must be weighted on each corner by a minimum of 50 lbs.
- All food vendors will be assigned a location on the street

### **Tear-Down:**

- **Vendors may leave the event early by walking their items out to their vehicles. No vehicles will be allowed in the park.**

### **Additional information:**

- There are no refunds for weather or vendor cancellations.
- **NO PETS** are allowed in the park during the event, with the exception of Service Animals.
- Please keep your booth area neat and clean.

### **Activities/Products Not Permitted:**

- NO additional items, not listed on your application may be sold without prior permission.
- Silt Heyday will not accept any vendors that wish to sell, advertise, or promote the use of marijuana or marijuana accessories. Marijuana is not allowed to be sold, smoked, or consumed at the event.

### **Final Approval:**

- Selected applicants are responsible for observing all rules and regulations, including those stated in all future mailings, e-mails and communications. The Silt Heyday committee reserves the right to accept or not to accept any exhibitor(s) and sales items for any reason whatsoever.
